
## Egg production in the EU

## **Production**

There are almost 363 million laying hens in the EU-27 producing 6.9 million tonnes of useable eggs / egg product per annum. Average egg consumption in the EU-27 is 12kg/capita/annum (Eurostat, 2011).

France and Spain are the largest egg producers, followed by Italy and Germany then the Netherlands and the UK (Figure 1) (European Commission, 2010). France is the 10<sup>th</sup> largest producer in the world (accounting for 1.5% of total production), whilst China is by far the largest producer accounting for 37.5% of production (FAOstat, 2012a). In 2009, the EU exported 188,000 tonnes and imported 35,000 tonnes of egg / egg product. Globally, the Netherlands is the largest exporter of eggs / egg product (26.4% export share) whilst Germany is the largest importer (27.3% of import share) (FAOSTAT, 2012b).

Figure 1. Top 6 egg producing countries in the EU by percent share of production. Data labels indicate '000 tonnes of useable egg production by country (% of EU production).



Around 60% of the world's eggs come from laying hens kept in cages. The proportion of hens in different production systems is given in Table 1 for the top 6 EU producing countries (European Commission, 2011).

## Legislation

Use of the barren-battery-cage in the EU is prohibited with effect from 1 January 2012 (Council Directive, 1999). The legal requirements for the different production systems are given in Table 2. Many producers in various countries have not have converted their battery-cages, so will produce eggs from banned systems. It is estimated that almost 3% of laying hens in the EU are still in barren-battery-cages; almost 84% and 56% of laying hens in Spain and Italy are in battery cages (European Commission, 2011).
